BOARD MEETING

DECEMBER 18, 2008

MINUTES

The New Mexico Junior College Board met on Thursday, December 18, 2008, beginning at 4:00 p.m. in the Zia Room of Pannell Library. The following members were present: Mr. Larry Hanna, Chairman; Ms. Patricia Chappelle, Secretary; Mr. Phillip Jones; Mrs. Mary Lou Vinson; Mr. Ron Black; Mrs. Yvonne Williams; and Mr. Guy Kesner.

Mr. Hanna called the meeting to order and welcomed visitors and guests present: Michelle Fox, Hobbs News Sun.

Upon a motion by Mr. Jones, seconded by Mrs. Vinson, the agenda was unanimously adopted, as presented.

Upon a motion by Mrs. Williams, seconded by Mr. Black, the Board unanimously approved the minutes of November 20, 2008.

Under *President's Report*, Dr. McCleery shared with the Board a letter from Judge Clingman regarding the PTK Foster Kids Christmas. Calvin Smith and Mary Lyle reported on the recent "Christmas at the Museum." Michael Rutledge showed an ITV – Distance Education video. Dr. McCleery shared a brochure developed by David Jett. In closing, Dr. McCleery presented Guy Kesner with his five year service pin.

Under New Business, Scotty Holloman presented the new 403(b) Plan and the revision of the Supplemental Retirement Plan for Board consideration. Upon a motion by Mr. Kesner, seconded by Mrs. Williams, the Board unanimously adopted the Resolution of the Board of New Mexico Junior College Adopting a Written 403(b) Plan. Upon a motion by Mr. Kesner, seconded by Mrs. Williams, the Board unanimously adopted the Resolution of Board of New Mexico Junior College Regarding the New Mexico Junior College Supplemental Retirement Plan. Upon a motion by Mr. Black,

seconded by Ms. Chappelle, the Board unanimously voted to table agenda item E.3. Consideration of Revision of Flexible Benefits Plan.

Dan Hardin presented the November financial reports and with a motion by Mr. Jones, seconded by Ms. Chappelle, the Board unanimously approved the expenditures for November, 2008.

Jeff McCool and Larry Sanderson presented a request for change in degree offerings. The request will be sent to The Higher Learning Commission for a "Change in Educational Offerings" which involves an amendment of accreditation status to allow the college to issue degrees earned fully online. Upon a motion by Mr. Black, seconded by Ms. Chappelle, the Board unanimously approved the following resolution. The NMJC Board approves plans for offering AA, AS and AAS degrees online beginning in the summer semester 2009. Dr. Steve McCleery is authorized to present a request for Change in Educational Offerings to the Higher Learning Commission on behalf of this Board and the institution.

Dr. McCleery presented a Resolution for the Board Election. Upon a motion by Mrs. Vinson, seconded by Mr. Jones, the Board unanimously adopted the resolution.

Dr. McCleery presented a New Mexico Education Services Center Implementing and Joint Powers Agreement for Board consideration. The Implementing Agreement is made for the purpose of detailing the expectations and understanding of the Council to manage the affairs of the NMESC. The Joint Powers Agreement allows for the continuing operation of the NMESC and supersedes JPA dated March 6, 2006.

Mr. Hanna called for comments from the public. There being none, the next regular board meeting was scheduled for January 20, 2009, beginning at 4:00 p.m.

Upon a motion by Mrs. Vinson, seconded by Ms. Chappelle, the board meeting adjourned at 5:15 p.m.

RE: Expenditure and Revenue Reports for December 2008

December is month six or 50% of the budget for the 2008/2009 fiscal year. The expenditure report represents expenditure totals that include funds expended and encumbered. The total year to date funds expended and/or encumbered through the month of December is \$19,086,041.00.

The total current unrestricted fund expenditures for Instruction & General through December are \$9,308,886.00, which is 48% of the projected budget. The total for Current Unrestricted Funds is \$11,827,236.00, which is 50% of the budget. All areas have normal expenditures for this time of year as compared to prior years. Because of encumbrances for maintenance agreements or seasonal expenditures the percentage of budget expended are reasonable.

In the Restricted Funds the expenditures in the Grant area is increasing. We continue to monitor the expenditures in the Grants and request the drawdown from the state and federal agencies. Restricted Student Aid will have the big Pell payout in January. Total amount of restricted funds expended through December of 2008 is \$2,547,468.00.

Year to date Plant funds expended is mainly encumbered funds for the various institutional projects as well as the upcoming Central Plant and electrical upgrade projects. In the private funds the \$411,094.00 expenditure is for the paving project at the Western Heritage Museum.

Expenditures through December 2008 were \$19,086,041.00 or 38% of the budget.

Total Current Unrestricted revenue received in December 2008 was \$4,152,567.00, with the year to date total of 16,758,439.00. This mostly consists of the tuition and fees, the monthly allocation from the state, the Oil and Gas Income, Oil and Gas Equipment tax income, and property tax revenue.

Tuition and Fees collected in December was \$496,744.00 as we collect tuition and fees for the spring semester. The State Appropriation for December was \$1,237,675.00, which consists of our normal monthly allotment and in December we received our funding from the HED for compensation and other special funding. HED issues some of the special funding and compensation twice a year. Oil and Gas tax revenue for the first six months of the fiscal year is \$4,187,159.00 over the projected budget; we received \$920,047.00 in December for the month of November. We have received very little Oil & Gas Equipment tax revenue at this point. But we will be receiving a large check by the middle of January. The property tax revenue for December was \$1,102,110.00; we were not expecting these funds as we were told that they would come in January. We are expecting more revenue in January and then again in June. Revenue for Auxiliary Enterprises is stronger this year; we are very pleased with the increase in sales at the Bookstore and for housing.

Restricted funds had some drawdown revenue in December. Total restricted fund revenue for the year is \$2,298,017.00. There will be another large drawdown in January or February for restricted student aid.

There was no drawdown in Plant Funds in December.

Total revenue for the month of December 2008 is \$4,307,958.00, with year-to-date revenue of \$19,519,716.00 or 59% of projected budget.

The Oil and Gas report reflects the strong mill levy revenue from Oil and Gas and Oil and Gas equipment taxes. The total budget through December for Oil and Gas is \$2,100,000.00. The total Oil and Gas revenue through December of 2008 (which includes the accrual of \$350,000) is \$6,279,016.00, which is \$4,179,016.00 over the total budget for the year.

The investment report shows an ending balance of \$11,625,000.00, as we had no activity in the Local Governmental Investment Pool in December. We have attached a letter from the Local Government Investment Pool that brings you up to date as to the status of our funds in the LGIP.

This concludes the Financial Report for December 2008.
